10. STATEMENT OF SIGNIFICANCE

Quarantine Station (fmr), Woodman Point, comprising a complex of timber and asbestos early Twentieth century buildings, limestone, brick and asbestos Quarantine Quarters in Victorian Regency style, timber and asbestos Residence No. 1 in Inter-War Californian Bungalow style, brick and asbestos Residence No. 2, brick Residence no. 3 in Post War International style, crematorium, cemetery, munitions bunkers, Asiatic Quarters ruins, Morgue ruins, railway ruins, bunker building, Small Pox Road, memorial plaque, two mature Norfolk Island Pines and natural coastal vegetation has cultural heritage significance for the following reasons:

the place is a rare example of a quarantine station in Western Australia and played an important role for nearly 100 years in preventing contagious infections and diseases from spreading into other areas of the State:

the place demonstrates quarantine practices from the late nineteenth century to the 1970s through the layout and design of its buildings and associated technical equipment and provides evidence of nineteenth century burial practices for those who died in quarantine;

the place includes a substantial and intact complex of similarly designed and distinctive early twentieth century buildings and is nestled in a picturesque natural coastal environment on a small peninsular:

the Quarantine Quarters is a good example of a Victorian Regency style residence with unusual colonial features, and the Dining Room, Laundry, and Disinfecting block exhibit excellent timber ceilings, trussed roofs and timber portal arches: the place was a disembarkation point, and therefore the first experience of Australia, for many overseas visitors and new migrants from 1886 to the 1970s, including participants of the Group Settlement Scheme of the 1910s and 1920s:

the dedication of the place for quarantine and defence purposes since 1836 and its deliberate isolation from mainstream development has resulted in the preservation of a rare pristine natural coastal environment:

the Observation Ward, First Class Quarters and Second Class Quarters are good examples of the work under the supervision of W. B. Hardwick, PWD Chief Architect between 1917 – 1927;

the graves and memorial at the Cemetery demonstrates the bravery of employees at quarantine stations, specifically the nurses from the Australian Army Nursing Service who volunteered at the place in 1918/19, four of whom died from Spanish Flu whist treating the patients with the disease; and

the place is highly valued by generations of Western Australians as a popular recreation camp from 1979 to present (2004).

The transportable shed, Tool Shed (1973), and pump house are of little heritage significance.
