# 11. ASSESSMENT OF CULTURAL HERITAGE SIGNIFICANCE

The criteria adopted by the Heritage Council in November 1996 have been used to determine the cultural heritage significance of the place.

# 11.1 AESTHETIC VALUE\*

*Dalgety Wool Store (fmr)* is significant as an outstanding example of a large-scale utilitarian warehouse in a late version of the Federation Warehouse style of architecture. (Criterion 1.1)

*Dalgety Wool Store (fmr)* demonstrates design achievement in the innovative structural planning of 1922/23 and 1927, which enabled the addition of an extra floor by raising the roof in 1944. (Criterion 1.2)

*Dalgety Wool Store (fmr)* is significant as a landmark in the streetscape due to its monumental scale and form. It is an impressive entry statement from the east to the central city Fremantle. (Criterion 1.3)

The bold utilitarian character of *Dalgety Wool Store (fmr)* contributes to the aesthetic character of the Port of Fremantle, as its unique character is integral to the associations with the harbour and port activities. (Criterion 1.4)

### 11. 2. HISTORIC VALUE

*Dalgety Wool Store (fmr)* demonstrates the development of the wool industry in Western Australia from post World War I to the late 20th century. As the place was purpose built for the industry, it illustrates practices of wool storage, display and sale and the remaining equipment demonstrates some of the practices and processes in the place. (Criterion 2.1)

*Dalgety Wool Store (fmr)* is the oldest remaining wool store in the strip adjacent to the harbour in Fremantle. The place is an example of one of the earliest wool stores built in the area, which became dominated by the presence of wool stores throughout the 20th century. (Criterion 2.2)

*Dalgety Wool Store (fmr)* was commandeered during World War II by the United States Navy 7<sup>th</sup> Fleet as part of the combined allied war effort. (Criterion 2.2)

*Dalgety Wool Store (fmr)* has strong associations with the firm Dalgety and Co who were significant in the development of the wool industry in Western Australia and Australia. (Criterion 2.3)

The architectural firm Hobbs, Smith and Forbes (and subsequent derivations of the firm) have been closely associated with the place since 1922/23 as they designed the original building and several of the subsequent additions. (Criterion 2.3)

The place demonstrates the significant achievement of Dalgety and Co in establishing their wool broking business in Fremantle and maintaining their presence in the city since 1892. It also demonstrates the achievement of the wider wool industry in developing facilities to market wool professionally nationally and internationally. (Criterion 2.4)

#### 11. 3. SCIENTIFIC VALUE

*Dalgety Wool Store (fmr)* is significant for its potential to reveal information about the practices of wool storage and display. The remaining equipment would contribute to this understanding. The design of the building is of value for its ability to demonstrate the principles of integrated planning for future expansion. (Criterion 3.3)

# 11. 4. SOCIAL VALUE

*Dalgety Wool Store (fmr)* is significant as evidence of the dominant role the wool industry played in the development of the town of Fremantle and the economy of Western Australia. (Criterion 4.1)

*Dalgety Wool Store (fmr)* is significant to the Fremantle community, generations of people associated with the wool industry and the wider community as the place has helped to shape the identity of port of Fremantle and the wider community's acknowledgement of the significance of the wool industry to the economy of Western Australia. (Criterion 4.1)

The strong physical presence of *Dalgety Wool Store (fmr)* and its continuity of function since 1922/23 contribute to the community's sense of place. (Criterion 4.2)

# 12. DEGREE OF SIGNIFICANCE

#### 12. 1. RARITY

*Dalgety Wool Store (fmr)* is an uncommon building, as the specific purpose within the wool industry for which it was designed is no longer practiced. (Criterion 5.1)

*Dalgety Wool Store (fmr)* represents a distinctive way of life and work process that no longer exists, where the storage, processing and export took place adjacent to a port. (Criterion 5.2)

# 12.2 REPRESENTATIVENESS

*Dalgety Wool Store (fmr)* demonstrates the principal characteristics of an extensive wool storage facility, as evidenced in Fremantle and throughout Australia, with its imposing street frontage, expansive structural post and beam structure throughout three storeys and the extra floor and natural lighting design for the additional buyers floor added in 1944. (Criteria 6.1)

*Dalgety Wool Store (fmr)* is a fine representative example of an imposing double frontage warehouse building in a late version of the Federation Warehouse style of architecture. (Criteria 6.1)

*Dalgety Wool Store (fmr)* is representative of and demonstrates the range of activities associated with the wool industry Western Australia, located harbourside in the port city of Fremantle to facilitate the business of storage and export. (Criteria 6.2)

#### 12.3 CONDITION

Dalgety Wool Store (fmr) overall is in fair condition. There is evidence of moisture ingress through rising damp, drainage issues and roof problems. The structural report highlights a number of structural issues that are supported by the evidence of structural intervention through most floor/ceiling connections as well as the north east wall (1927) and north west wall (1922/23). The structural report further raises issues of the structural adequacy of the post and beam structure throughout and the footings and foundations of the site. The metal and timber window frames have disintegrated to poor condition and in most cases the metal frames that are still remaining on the south west wall are beyond redemption. There is no evidence that maintenance takes place.

#### 12.4 INTEGRITY

*Dalgety Wool Store (fmr)* has a high degree of integrity. The place has predominantly had a warehousing function, with associated facilities. Extensions at various times, and incremental changes have enabled the continued use of the place, continuing a general warehousing function. The long-term sustainability of the place as a warehouse is high.

# 12.5 AUTHENTICITY

*Dalgety Wool Store (fmr)* overall has a high degree of authenticity. The original 1922/23 fabric is evident, as is the 1927 extension and alterations that took place to facilitate the extension. No evidence remains of the original roof on the second floor, but clearly the 1944 roof remains intact, with some structural intervention. Structural support intervention is evident throughout. The 1942/1952 wool store reveals original form and fabric with some interventions that facilitated the ongoing function.
