#### 11. ASSESSMENT OF CULTURAL HERITAGE SIGNIFICANCE

The criteria adopted by the Heritage Council in November 1996 have been used to determine the cultural heritage significance of the place.

Art Gallery Administration Building and Centenary Galleries are significant elements in their own right as well as contributing to the complex. Values relating only to these elements have not been included in the following section.

#### 11. 1 AESTHETIC VALUE\*

Main Gallery Building is a fine example of the Late Twentieth Century Brutalist style. The aesthetics of the interior spaces are of a high order providing a variety of visual experiences and their functionality has been much applauded. The fountains and reflective ponds are an integral part of the setting. (Criterion 1.1)

Gerhard Mack's *Der Rufer*<sup>1</sup>, erected near the pond, is a fine individual artwork that is well known due to its prominent location and contributes to the overall setting of *Art Gallery of Western Australia Complex*. (Criteria 1.2 & 1.3)

Art Gallery of Western Australia Complex is a cultural landscape consisting of fine examples of Late Twentieth Century Brutalist, Federation Romanesque and Federation Second Empire style buildings, and is an integral component of the wider Perth Cultural Centre. (Criterion 1.3)

## 11. 2. HISTORIC VALUE

Main Gallery Building was built to replace its predecessor in Beaufort Street, which was part of the historic museum, art gallery and library complex, and marks the second mineral boom and the maturing of the State and its cultural institutions. (Criterion 2.1)

The construction of Main Gallery Building from 1977 was made possible by improved economic conditions resulting from the mineral boom of the 1970s and the impetus provided by the State's impending Sesquicentenary in 1979. The Alexander Library, also part of the Perth Cultural Centre, was commenced in the same year. (Criterion 2.2)

Main Gallery Building was designed by Public Works Architect K (Charles) Sierakowski, structural engineer Philip Nadebaum and private architectural firm, Summerhayes and Associates. Sierakowski followed the Bauhaus house precept that form follows function, accounting for the excellent internal spaces and Brutalist exterior. This design principle was popular in European galleries at the time and Sierakowski had previously used the principle in the design of London's Hayward Gallery. (Criteria 2.3 & 2.4)

Art Gallery of Western Australia Complex is closely associated with Art Gallery Director, Robert Bell, who was the first Curator of Craft in Australia. (Criterion 2.3)

#### 11. 4. SOCIAL VALUE

Art Gallery of Western Australia Complex is highly valued for its function as a cultural institution. The internal spaces, collections and experiences, offered by the Art Gallery and which take place in the building, are valued by the community. (Criterion 4.1)

Main Gallery Building's receipt of the Royal Australian Institute of Architects' Architecture Design Award in 1979 is evidence of the esteem in which the architectural profession held the place. (Criterion 4.1)

The institution, collections and building itself contributes to the community's sense of place as part of the Perth Cultural Centre. (Criterion 4.2)

#### 12. DEGREE OF SIGNIFICANCE

#### 12. 1. RARITY

Based on available information (no comprehensive survey of art gallery design in Australia is readily available), the planning principles employed at Main Gallery Building are unusual. (Criterion 5.1)

The use of the slab and shear head column system in Main Gallery Building was innovative in Western Australia at the time and remains an uncommon construction form. (Criterion 5.2)

#### 12. 2 REPRESENTATIVENESS

Art Gallery of Western Australia Complex was conceived as part of the Perth Cultural Centre complex which was developed in the 1970s. Main Gallery Building is representative of the State's maturity and of the second wave of development of the State's cultural institutions following post World War Two recovery and the 1970s mineral boom. (Criterion 6.2)

Main Gallery Building is a fine representative example of the Late Twentieth Century Brutalist style, and succeeds best within this idiom with the quality of the interior spaces. (Criterion 6.2)

#### 12. 3 CONDITION

Overall, Main Gallery Building is in fair to good condition.

Internally, levels 1 and 2 of the building are in good condition. Level 3 is generally in good condition, with some minor defects associated with movement and moisture ingress. Level 4 is in fair condition. The bituminous built up roof and paving units over it are in poor condition and there are instances of cavity tray failure.

There is evidence of serious deterioration of the face blockwork due to mortar failure and the expansion of joint reinforcement. The exposed exterior ply faced doors at roof level are also in an advanced state of deterioration.

The fabric roof of the café has reached the end of its design life and needs to be replaced.

#### 12.4 INTEGRITY

Main Gallery Building has remained in use for its intended purpose since construction and therefore has a high degree of integrity.

## 12. 5 AUTHENTICITY

Main Gallery Building has had few major changes in the years since completion, notwithstanding minor adaptive changes to levels 1, 3, 4 and 5. Level 2 has had a major reorganization of retail and public service functions, without impinging on the major gallery spaces and overall presentation.

Overall, the place has a high degree of authenticity.
