11. 1 AESTHETIC VALUE*

Red Mill Store is a fine, intact example of a Victorian two-storey terrace shop and residence. The 1920s single-storey shop addition makes a striking visual contrast between the two architectural styles. (Criterion 1.1)

Red Mill Store has landmark qualities and contributes to the late 19th century character of the streetscape which has considerable unity in architectural style. (Criterion 1.3)

11. 2. HISTORIC VALUE

The place has combined the function of residence and commercial retail outlet since 1897. For the first few years it served as a construction and hardware business, then for 81 years as produce merchant and general grocery store, and subsequently as a convenience store and delicatessen. The property provides a representative example of a general store that was once a common phenomenon. (Criterion 2.1)

1. 4. SOCIAL VALUE

Red Mill Store contributes to the community's sense of place, having been in use continuously as a local store on one of the main thoroughfares of Bunbury for more than 100 years. (Criterion 4.2)

12. DEGREE OF SIGNIFICANCE

12. 1. RARITY

Red Mill Store is rare as a surviving commercial business in a predominantly residential area. The degree of intactness of the external and internal shop display windows, fittings and verandah details is particularly unusual. (Criterion 5.2)

12. 2 REPRESENTATIVENESS

Red Mill Store is a fine and comparatively intact example of a Victorian shop and residence which was typical of its day, complete with internal fittings, display windows and verandah details. (Criteria 6.1 & 6.2)

12.3 CONDITION

The condition of the place is good condition, albeit there are substantial weathering problems due to water ingress, rising damp and damp penetration along the western external wall due to the aging of the bricks.

12. 4 INTEGRITY

The integrity of the 1897 building and the 1927 shop extension is considered high as the place continues to be utilised as a combined shop and residence.

12.5 AUTHENTICITY

The authenticity of the 1897 and 1927 shops is high. All lost details are recorded and could be reconstructed. This is particularly the case with the first storey verandah section.

The internal shop fitouts, including the moveable shelving and counter in the 1927 shop, are all authentic, although they are not in their original positions.

The rear ground level additions and rear garden have lost their authenticity due to substantial renovations or site disturbance.

Interior decorative details have been removed and altered in the residence.
