11. ASSESSMENT OF CULTURAL HERITAGE SIGNIFICANCE

11.1 AESTHETIC VALUE*

St John the Baptist Catholic Church, Moora is a good, simple example of a stone church designed with vernacular ecclesiastical characteristics, showing some influence of the Federation Gothic architectural style. (Criterion 1.1)

St John the Baptist Catholic Church, Moora, together with the Presbytery, Nuns' residence and Catholic School, forms a distinctive cultural environment of ecclesiastical buildings. (Criterion 1.3)

11. 2. HISTORIC VALUE

St John the Baptist Catholic Church, Moora was constructed in 1908, and has continually served the local Catholic community with services including worship, celebrations, and other events since this time. (Criterion2.1)

St John the Baptist Catholic Church, Moora was used as a school as well as a church between 1913 and 1929, when a purpose-built schoolroom was constructed nearby. (Criterion 2.2)

St John the Baptist Catholic Church, Moora was built under the guidance of the Benedictine Monks of New Norcia at a time when Moora was under their canonical jurisdiction. (Criterion 2.3)

St John the Baptist Catholic Church, Moora was constructed by local builder D.W. Griffiths, who also quarried the stone, and made the bricks at his property in Moora, and was responsible for the construction of a number of other significant buildings in the area. (Criterion 2.3)

11. 4. SOCIAL VALUE

St John the Baptist Catholic Church, Moora has been a focus for the social and spiritual lives of the local Catholic community in Moora since 1908, and is also valued by the community for its use as a school between 1913 and 1929. (Criterion 4.1)

St John the Baptist Catholic Church, Moora contributes to the Catholic community of Moora and district's sense of place as an important location for worship, weddings, funerals, and other events. (Criterion 4.2)

12. DEGREE OF SIGNIFICANCE

12.1. RARITY

St John the Baptist Catholic Church, Moora is an unusual example of a church that incorporates accommodation for the priest within the main building, with the parish priest between 1909 and 1948 living in the two rooms at the rear of the church. (Criterion 5.2)

12. 2 REPRESENTATIVENESS

St John the Baptist Catholic Church, Moora is a representative example of a rural vernacular Federation Gothic style church constructed of local stone. (Criterion 6.1)

St John the Baptist Catholic Church, Moora demonstrates the characteristics of religious and cultural activities associated with the Catholic Church in a rural community since 1909. (Criterion 6.2)

12.3 CONDITION

Maintenance has taken place over a period of many years. However, the long term effects of the flood damage and the lack of regular programmed maintenance and limited financial resources is becoming evident. Overall *St John the Baptist Catholic Church, Moora* is in fair to good condition.

12.4 INTEGRITY

The original design and functional intention of the place is clear. *St John the Baptist Catholic Church, Moora* has retained a high degree of integrity.

12.5 AUTHENTICITY

The original fabric has been retained for the most part and *St John the Baptist Catholic Church, Moora* has a high degree of authenticity.
