# 11.1 AESTHETIC VALUE\*

Barracks Arch is a fine example of Victorian Tudor architecture with dichromatic Flemish bond brickwork. (Criterion 1.1)

The place is a major landmark, as the remnant of a much larger significant building that has visually terminated views to the west of St George's Terrace, Perth's premier business street, from 1868 to the present. (Criterion 1.3)

# **11.2. HISTORIC VALUE**

Barracks Arch is the only surviving remnant of the barracks erected to house soldiers of the enrolled pensioner force who remained on duty after the Imperial Government removed the regular troops in 1868, marking an important evolution in the history of the State. (Criterion 2.1)

The place is a symbol of a growing awareness of the value of buildings of cultural heritage significance in Perth in the 1960s. Its retention was a direct result of a groundswell of popular support and protest in the face of government proposals for demolition. (Criterion 2.1)

The place has historic value for its association with transportation of convicts and their Enrolled Pensioner Guards, for whom it was built. (Criterion 2.2)

Barracks Arch has a long association with the Public Works Department (occupied the site from 1904 to 1966) and a succession of its notable figures who have had a strong impact on the built environment of Perth, most notably James Manning and Richard Roach Jewell, who is generally credited with the design of the place. # **12. DEGREE OF SIGNIFICANCE**

#### 12.1. RARITY

*Barracks Arch* is a rare Western Australian example of both a barracks and the remnant of a 19<sup>th</sup> century Victorian Tudor building with several of the identifying characteristics ascribed to that style, namely: a battlement, quioning, string courses, a Tudor arch, a pointed arch and label moulds over windows. (Criterion 5.1)

# 12.3 CONDITION

The place is in good condition with some deterioration to the brickwork and timber joinery.

# 12.4 INTEGRITY

*Barracks Arch*, as a remnant gateway to a large building complex, since demolished, has a low degree of integrity. The original intention is not intact and there has been no regular activity at the place since the structure of the whole barracks complex was modified in 1968.

# 12.5 AUTHENTICITY

The place has a high degree of authenticity. The majority of the external fabric is in its original state. Although the west elevation was constructed in 1968 the bricks were retrieved from the demolition of the barracks building and are of the same vintage as those used in the rest of the arch.
