# 11. ASSESSMENT OF CULTURAL HERITAGE SIGNIFICANCE

# 11. 1 AESTHETIC VALUE\*

Community Education Centre is a fine and intact example of a Victorian Georgian residence. (Criterion 1.1)

Community Education Centre is a landmark in the streetscape of Gregory Street/Marine Terrace as it presents a grandness of scale and architectural

detail amongst smaller scale buildings and simple stone residences. (Criterion 1.3)

Community Education Centre is an important element in the historic port precinct of Geraldton that includes the adjacent Geraldton Hotel. (Criterion 1.4)

#### 11. 2. HISTORIC VALUE

Community Education Centre is associated with the provision of hostel facilities for country students, by the Anglican Church, in the first half of the Twentieth century. (Criterion 2.1)

Community Education Centre is closely associated with the Trefusis Aerated Water and Cordials Manufactory, a company that supplied Western Australians with aerated water, cordials and syrups from 1875 until 1970. (Criterion 2.2)

As an administrative, training and educational support centre for the Midwest region from 1973 until 2003, *Community Education Centre* represents the improvements in educational facilities in Australia following the 1974 Karmel Report which identified deficiencies in the education system in Australia and resulted in funding being provided to address those issues. (Criterion 2.2)

Community Education Centre was built by Martin Hosken, licensee and manager of numerous hotels in the mid west region, mine manager, and creator of the Trefusis Aerated Water and Cordial Manufactory Company, a company that provided its products for the mid west region from 1876 until 1931. (Criterion 2.3)

#### 11. 3. SCIENTIFIC VALUE

The cellar and rear yard area of *Community Education Centre* demonstrates the potential to reveal, through archaeological investigation, information that could contribute to a greater understanding of the aerated water factory functions in the 1870s. (Criterion 3.2)

# 11. 4. SOCIAL VALUE

Community Education Centre is highly valued by former students from the Midwest region who boarded there between 1939 and 1968 while attending school in Geraldton. (Criterion 4.1)

Community Education Centre is highly valued by the community as an administrative, training and educational support centre for the Midwest region from 1975 until 2003. (Criterion 4.1)

Community Education Centre contributes to the local community's sense of place as an early building that is part of the historic port area of Geraldton. (Criterion 4.2)

#### 12. DEGREE OF SIGNIFICANCE

### 12. 1. RARITY

Community Education Centre is rare in Geraldton as a Victorian Georgian building. (Criterion 5.1)

#### 12. 2 REPRESENTATIVENESS

Community Education Centre is a fine example of a limestone and shingle Victorian Georgian residence. (Criterion 6.1)

Community Education Centre is important in demonstrating the establishment of a residence and business in the vicinity of the Geraldton port and the hotel opposite, in the late nineteenth century. (Criterion 6.2)

Community Education Centre represents the practice of using relatively large, former residences, in city and towns, for the provision of high school hostel facilities.

#### 12. 3 CONDITION

Overall, *Community Education Centre* is in fair to good condition, due to extensive refurbishment in the late 1970s, and regular maintenance and works programs that have taken place. There is evidence of extensive termite damage, some rising damp and weathered verandah timbers.

#### 12. 4 INTEGRITY

Community Education Centre functioned as a residence since construction in c.1875 until the late 1960s. Community Education Centre has retained a high degree of integrity.

# 12. 5 AUTHENTICITY

The place shows considerable evidence of changes to the fabric, including roof replacement, verandah floor replacement, external wall surface treatments, verandah post replacements on the exterior, however, much of the interior remains intact except for the kitchen. *Community Education Centre* demonstrates a high degree of authenticity.

Additional information provided by Regional Heritage Advisor for the Mid-West, 28/10/2003 –

The place presents a grandness of scale and architectural detail, which stands out in this historic precinct, which largely consists of smaller scale buildings (other than the Hotel opposite) and simple stone residences. It retains a high level of intactness and integrity. Although there are a number of additions to the rear and side, the main building together with sections of the front boundary wall still retain a high degree of authenticity and streetscape value.
