10. STATEMENT OF SIGNIFICANCE

Parry Street Precinct, a row of semi-attached and attached single storey brick residences of various styles, has cultural heritage significance for the following reasons:

the precinct is rare as an example of a relatively intact streetscape of late nineteenth century and early to mid twentieth century buildings still extant the City of Perth;

the place has significance as a cohesive streetscape of modestly and elaborately detailed residential buildings, encompassing a variety of architectural styles dating from the late nineteenth century and early to mid twentieth century;

the precinct forms an integrated group of single storey residential buildings, which contribute, to the historic character of the area and to the community's sense of place;

the place reflects the expansion and development of residential buildings on the city fringes during the rapid population increase of the 1890s gold boom and the early years of the twentieth century;

the place collectively demonstrates the standard of residential accommodation built in the area during the late nineteenth and early twentieth century and the subsequent changes in ownership illustrate the social mobility of the Northbridge population as expansion of transport services enabled the more well-to-do members of society to move further afield to newly developed suburbs; and,

the place is important for its role in providing low cost housing for residents in Northbridge.
